rooms and kitchen. The primary bedroom is a generous size, able to fit traditional bedroom furniture easily. A lockout door leads to the mini-suite where there is a kitchenette, large bedroom area, two closets and full bathroom. This unit will be sold partially furnished. HOA dues for this unit include access to all of Sea Trail's amenities, master insurance, exterior maintenance, elevator maintenance, roof maintenance, landscaping, private

trash service and pest control. This location does not get any more convenient. Literally around the corner from the town area of Sunset Beach with shopping, dining and small businesses and down the street from the pristine sands of Sunset Beach. ## IMPORTANT CONTACTS & INFO

- HOA dues are paid quarterly in the amount of \$4,747.60 per year.
- Sea Trail Master Association dues are \$1150 per year
- Total HOA dues for both are \$5,897.60. Dues include exterior maintenance, roof maintenance, landscaping/irrigation, pest control, master insurance, private trash service, and access to all Sea Trail amenities.
- There was a **special assessment** to all Champions condo owners this year. The amount for this unit was \$3249. Half of that has been paid already and the remaining half will be paid by the seller prior to or at settlement.
- Sea Trail amenities include two owners' amenity centers, two outdoor pools, fitness room, exercise room, private parking lot at Sunset Beach, sauna, hot tub, Pink Palace main room and ancillary meeting rooms, lending library, horseshoe pits, bocce courts, chapel and many organized activities


